



**GLENARA KANNAN BALL**  
**2022-2023 FROZEN SEMEN TERMS AND CONDITIONS**  
**CONTRACT FOR NEW ZEALAND USE ONLY**

Balmoral Equestrian “BML” is excited to be offering limited doses of frozen semen to their stallion Glenara Kannan Ball in New Zealand. Due to limited supplies BML will be selling straws on a per dose basis.

**FEES:**

Frozen semen service fee for Glenara Kannan Ball is \$1400 plus gst NZD

1. Upon accepting this agreement, a non-refundable booking fee of \$500 plus gst NZD is due. This will nominate the mare named on this contract you have completed.
2. This entitles the mare owner for up to one dose/insemination.
3. Once the booking fee has been paid BML will authorise one dose (6 straws) to Glenara Kannan Ball.
4. The balance of \$900 plus gst NZD is payable on a 30 day positive pregnancy test.  
This means if your mare fails to become pregnant after using the dose/insemination the balance of the service fee is not required to be paid.
5. Any freight and distribution charges (transport of semen) are at the expense of the mare owner

## CONDITIONS OF USE:

1. The breeding season begins on the 1st August 2022 to 1st April 2023.
2. The semen must be used only on the mare nominated in the contract.
3. The semen handling and inseminations must be performed by an approved Veterinarian. Please see Cry NZ list of approved veterinarians.
4. The dose rate must be adhered to and all straws to be used in each dose. No splitting of doses.
5. If the last insemination was before more than 30 days and no veterinary certificate is provided that states that the mare is not pregnant, the service fee will be charged by Balmoral Equestrian. **It is the mare owners responsibility to inform Balmoral Equestrian that the mare is not pregnant otherwise a positive pregnancy will be assumed and invoiced from Balmoral Equestrian.**
6. The use of semen for ICSI is not allowed.
7. If the mare is for embryo transfer this must be disclosed to Balmoral Equestrian or CryNZ at the time of the flush.
8. If more than one embryo is achieved this must be disclosed to Balmoral Equestrian or CryNZ at the time of the flush.
9. Each viable embryo will incur a full service fee of \$1400 plus gst NZD (also when frozen).
10. No straws are to be destroyed or transferred or sold whatsoever
11. All insemination documents are to be completed and returned to Cry NZ with the empty straws after each insemination.
12. If semen is sent out but not used because the mare becomes unsuitable for any reason, the semen must be returned to Cry NZ at the mare owners expense before the end of the current breeding season, no later than 31 March each year.

## WARRANTY:

Balmoral Equestrian will provide one dose (6 straws) of quality semen per contract and will not be liable for lost, damaged or delayed semen due to circumstances beyond their control. Once the contract is signed and booking fee paid Balmoral Equestrian will release Glenara Kannan Ball semen from Cry NZ and the nominated mare owner is free

to order the doses as they are required for their chosen veterinarian by filling in the dispatch release form online from Cry NZ.
