Breeding Conditions for Balou Barbados 2025/26 Breeding Season.

Arundel Farm are excited to offer for the first time, Balou Barbados services for this upcoming breeding season. He will be available to a limited number of special mares. This exciting young stallion By Baloubet du Rouet out of Baledo by Bellini`s Boy. He is conformationally correct he has great presence, power and three floating expressive gates. He is a mid - size stallion and his beautiful roan colour and stylish markings are only out shone by his incredible intelligent nature. He is truly a versatile New Zealand stallion, perfect for the our breeders and riders as he possesses incredible ridability without compromise to his outstanding jumping technique. Balou Barbados is only available through Frozen semen.

Arundel Farm is committed to the breeding industry in NZ and so this contract is designed to encourage all breeders to invest with the service fee only payable on a 30 day positive pregnancy test.

Fees:

The Stud for Balou Barbados is \$1700 + gst.

1. Upon accepting this agreement, a non-refundable booking fee of \$700 plus gst NZD is due. This will nominate "the mare" named on this contract you have completed here online.

This means if your mare fails to become pregnant after the 3 doses/inseminations, the balance of the remaining stud fee (\$1,000) service fee is not required to be paid. Further doses may be provided by negotiation.

- 2. The balance of the stud fee, \$1000 + gst being payable on a 30 day positive pregnancy test.
- 3. Any freight and distribution charges (transport of semen) are at the expense of **the mare** owner.

CONDITIONS OF USE:

- 1. The semen must be used only on **the mare** nominated on this contract. This is **the mare** listed on the online booking form.
- 2. The semen handling and inseminations must be performed by an approved Veterinarian or an approved A.I technician and all Insemination documentation completed and returned to CryNZ.
- 3. The semen dose rate will accompany all shipment of Balou Barbados semen. The dose rate must be adhered to and all straws to be used in each dose. No splitting of doses.
- 4. The use of semen for ICSI is not allowed.
- 5. If **the mare** is for embryo transfer, this must be stated at time of booking and notified to Arundel Farm or CryNZ.
- 6. If more than one embryo is achieved this must be disclosed to Arundel Farm or CryNZ at the time of the flush.
- 7. Each viable embryo will incur a full service fee.
- 8. No straws are to be destroyed or transferred or sold whatsoever.
- 9. All insemination documents are to be completed and returned to CryNZ with the empty straws after each insemination.
- 10. If semen is sent out but not used because **the mare** becomes unsuitable for any reason, the semen must be returned to CryNZ at the mare owners' expense before the end of the current breeding season, not later than the 31st March each year.

CONDITIONS OF LIVE FOAL GUARANTEE & RETURN SERVICES:

Arundel Farm offers a Live Foal Guarantee. This means that if after the service fee has been paid in full, the nominated mare fails to produce a live foal or the foal fails to live within 24 hours after birth, the nominated mare is eligible for a return service the following season. The live foal guarantee is subject to the nominated mare being foaled at a professional and experienced horse stud, equine veterinary practice or professional and experienced stud master, which must be authorized by Arundel Farm prior to the nominated mare giving birth unless agreed to at a later date in writing between the parties.

The live foal guarantee expires after 2 seasons including the Current season.

Should the mare become unbreedable on the advice of an equine veterinarian please provide a veterinary certificate outlining this and provide it to Arundel Farm as soon as it becomes evident, then the nominated mare owner may nominate another mare for breeding.

This second mare must be approved as a suitable mare by Arundel Farm and provided that the live foal guarantee has not expired can be substituted in place of the nominated mare within this agreement by the consent of both parties. As such the Nominated mare owner must provide for the approval process the details outlined about the nominated mare at the beginning of this agreement. If the nominated mare ownership changes during pregnancy the live foal guarantee does not transfer to the new owner of the nominated mare unless a new

agreement is formed between Arundel Farm and the new mare owner. This is at Arundel Farm's discretion.

WARRANTY:

Arundel Farm will provide quality semen doses (3) per contract and will not be liable for lost, damaged or delayed semen due to circumstances beyond their control.

Once the contract is signed Arundel Farm will release the **Balou Barbados** semen from CryNZ and the Nominated Mare owner is free to order the doses as they are required for their chosen Veterinarian by filling in the Dispatch release form online.
