On completion of this online booking form you the **Mare owner** are agreeing to this contract and the terms set out below.

The agreement is between you the **Mare owner** and **Team Nijhof** the **Sire owner**. And covers the frozen semen of the nominated Team Nijhof stallion you have chosen on the booking form.

Please download a copy of these terms for your records.

Fees:

The service for all Team Nijhof Stallions are listed on the schedule, all fee are listed and to be paid in Euro directly to Team Nijhof on receiving an invoice.

- 1. Upon accepting this agreement, a non-refundable fee in Euro is due. This will nominate the mare named on this contract you have completed here online.
- 2. An Invoice for your chosen Stallion will be issued to you, with details for payment in Euro.
- 3. Once the invoice is paid, Team Nijhof will then notify CryNZ to release frozen semen one dose at a time up to 3 doses until the mare becomes pregnant.
- 4. Once the semen is released by Team Nijhof, the Mare Owner may, at any time contact CryNZ to arrange Dispatch and shipping your chosen Veterinarian.
 - Or fill out the dispatch form online.
- 5. Any freight and distribution charges (transport of semen) are at the expense of the mare owner.
- 6. If your mare fails to conceive after these three doses a 4th Dose may be purchased for an additional fee of 250 Euro.
- 7. All Insemination documents must be completed by the Veterinarian or A.I Technician and returned to CryNZ Ltd.

CONDITIONS OF USE:

1. The semen must be used only on the mare nominated on this booking form and contract. This is the mare listed on the online booking form.

- 2. The semen handling and inseminations must be performed by an approved Veterinarian or an approved A.I technician. All Vet and insemination costs are at the expense of the Mare owner.
- 3. The semen dose rate will accompany all shipment of Team Nijhof semen. The dose rate must be adhered to and all straws to be used in each dose. No splitting of doses.
- 4. The use of semen for ICSI is not allowed.
- 5. If the mare is for embryo transfer, this must be stated at time of booking and notified to Team Nijhof or CryNZ.
- 6. If more than one embryo is achieved this must be disclosed to Team Nijhof or CryNZ at the time of the flush.
- 7. Each viable embryo will incur a full service fee.
- 8. No straws are to be destroyed or transferred or sold whatsoever.
- 9. All insemination documents are to be completed and returned to CryNZ with the empty straws after each insemination.
- 10. If semen is sent out but not used because the mare becomes unsuitable for any reason, the semen must be returned to CryNZ at the mare owners' expense before the end of the current breeding season, not later than the 31st March each year.
- 11. If the mare owner has problems and wishes to change mares or stallions that can be possible, please contact Jeannette Benedict-Nijhof directly to make change to the contract and to enquire about the price difference in stallions.
- 12. Unless by written agreement with Team Nijhof, these semen return arrangements are only valid for two seasons.
- 13. At all times, Team Nijhof remains owner of the straws and unused semen-straws must be returned to CryNZ Ltd in New Zealand at the mare owner's expense.
- 14. If the breeder wishes to retain any remaining semen, for using with another mare or for the following year, then a new contract will need to be filled in and sent to Team Nijhof, and an additional service fee paid.

Team Nijhof will provide a DNA profile for all of their Stallions so breeders having paid their full service fee have access to the profile of their Stallion so the resulting foal can be Parentage DNA tested at birth.
